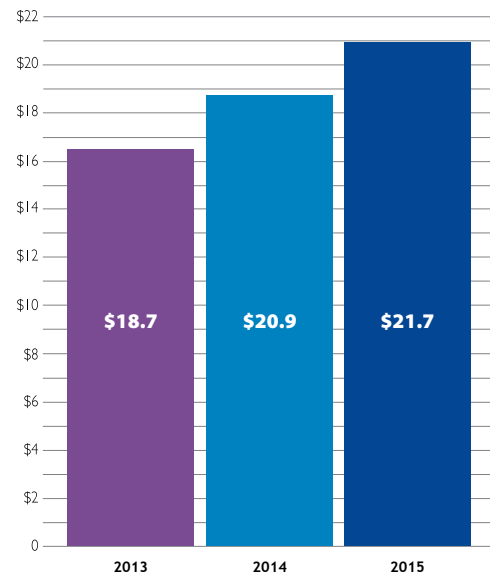
Reputation: Children's Home Society of Florida, supported by Children's Home Society of Florida Foundation, is a credible non-profit organization that has served children and families since 1902.
